**OBJECTIVE OF CO-OPERATION**

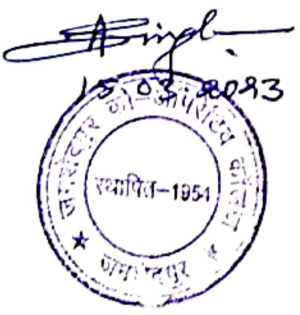
The objective of this Memorandum of Understanding (MoU) is to cooperate in educational projects in areas of mutual interest.

**ARTICLE-2**

### EXECUTING AGENCY

2. Janshedpur Women's University, Janshedpur appoints the Registrar, Janshedpur Women's University, Janshedpur

## ARTICLE-5

### FINANCIAL ARRANGEMENT

1. Any co-operation under this MoU is subject to the availability of funding sources and approval by relevant authorities.
2. Any specific project of joint interest will be detailed in a separate agreement, including financial and program specific arrangements.

## ARTICLE-6

### INTELLECTUAL PROPERTY RIGHTS

1. Each Party shall protect, within its territory, intellectual property rights of the other party in accordance with the domestic law in force in this respective countries.
2. In case of specific arrangement, programs or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with their respective laws and regulations.



## ARTICLE-7

### AMENDMENT

1. This MoU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MoU.
2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

Based on the principles of equality, reciprocity, and mutual benefit, Janshedpur Co-operative

College, Janshedpur (Kolhan University, Chaibasa) and Janshedpur Women's University,

Janshedpur hereby agree to explore the following avenues of educational exchange :

1. Student exchange program.
2. Curriculum development and Offering specially designed programs of study.
3. Collaborative Research projects.

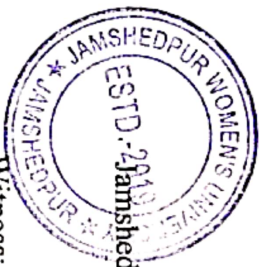
